**Purchase:** The Buyer hereby purchases from the seller the mini goldendoodle puppy described above for a total price of \_\_\_\_\_. A non-refundable deposit of \$500.00 must be paid to hold above puppy, with the remaining balance due at time of pick-up.

**Buyers Responsibilities**

Puppy must be examined by a licensed veterinarian within 10 days of going home, holiday weekends being an exception. The seller must be informed of the results of the vet check, whether good or bad, by midnight on the same day of the appointment either by email or phone message. If the buyer fails to do this, the guarantee becomes null/void.

Puppy must be provided with preventative care including (but not limited to) annual vet exams, following vet guidelines on de-worming, vaccinations, and heartworm prevention. The puppy must also be housed and cared for properly and fed a premium dog food.

**Health Guarantee**

The seller certifies that this dog is free from diseases and physical defects as appears to the eye unless otherwise stated below. The seller guarantees this dog against all life threatening congenital or hereditary defects (example: heart murmur over point 3, liver shunt, and crippling hip dysplasia) for up to 1 year of age. If the dog would be found to have any parasites, or any other condition that is not life-threatening (example: fleas, worms, skin irritations, kennel cough, coccidia, guardians, or ear mites, etc.) it is the buyer’s responsibility to treat these at the buyer’s expense.

The seller will not be responsible for factors beyond their control including, but not limited to: negligence, cruelty, accidental injury, exposure to disease-carrying animals, stress resulting from change in diet or environment, hypoglycemia, kennel cough, retained baby teeth, off bites, umbilical hernia, undescended testicles, inguinal hernia, or any other expense except as otherwise proved by law.

The buyer agrees to have the dog examined by a licensed veterinarian as soon after purchase as feasible. If the dog is not seen by a licensed veterinarian within 10 days from the date of purchase, all guarantees are voided as the dog is not the seller's responsibility, and no money shall be refunded.

If upon examination, a licensed veterinarian finds the dog to have a serious defect, then the buyer shall contact the seller within two business days and produce the animal to the seller's designated veterinarian within four business days of the vet visit. Buyer's failure to produce the dog within four business days for examination will nullify seller's obligation to replace, refund, or reimburse, except as otherwise provided by law. All dogs are being sold strictly as pets, not guaranteed show-quality animals.

The seller is not responsible for any medical expenses that are incurred. By owning a puppy, trips to the vet and bills are expected. The puppy has been vet checked before leaving the seller and found to be in good health. The puppy will not leave if it is showing any sign of illness or injury.

All items covered by the guarantee are by replacement only, with the seller choosing the replacement puppy. No refunds will be given in part or in full. The buyer is responsible for all shipping and transportation costs associated with returning an affected puppy and obtaining replacement puppy. If the buyer refuses to return the puppy, or have it euthanized, the right to a replacement puppy is forfeited, forever.

If the terms of this contract are not met it becomes null and void. By not signing the contract, the buyer will be purchasing the puppy AS IS with no guarantee or warranty. This contract is only good for the original buyer and is not transferable. This is the only guarantee set forth, no other warranties either expressed or implied. Should the buyer choose to pursue matter in the court of law, that place of jurisdiction is Bedminster NJ. The buyer will also be responsible for any attorney fees that the seller incurs.

This health guarantee is only valid between the Seller and the original Buyer and does not transfer if ownership of the dog changes. We offer lifetime support with all of our puppies and if the puppy is no longer wanted, we will take any of our puppies back from anyone at any time (NO REFUND unless otherwise noted in the contract).

### Conditions

1. If a hereditary disease is diagnosed, it must be designated severe, or life threatening, diminishing the quality of puppy/dog's life, and be confirmed by two independent veterinarians. Findings will be sent to Willow Paw including diagnostic data, x-rays, etc. and must be reviewed and agreed upon by a Veterinarian of Willow Paw's choosing. Willow Paw reserves the right to have puppy/dog examined by a Veterinarian of our choosing at our expense.
2. In the case of Hip dysplasia, proof by the Orthopedic Foundation for Animals (OFA) is required before any replacement/refund will be made. In the case of hip dysplasia, the health guarantee is void if the puppy's primary diet has not been a premium food, and/or puppy has been allowed to become overweight.

3. In the case of any eye disease, the dog's eye exam must be sent to the Canine Eye Registration Foundation (CERF) for judgment, and the statement confirming a debilitating disease sent to Willow Paw.
4. Puppy must have been kept current on yearly exams, heartworm tests and preventative, all vaccines including rabies. This health guarantee will be void if Buyer is unable to provide complete and accurate copies of their puppy's health care given on a regular basis.
5. If the puppy has been allowed to compete in Agility, run up and down stairs, or be a jogging partner, before the age of 12 months, this health guarantee will be void.
6. A dog that has been physically injured is not covered under this health guarantee.
7. It is the Buyer's responsibility to keep the puppy away from public places (such as puppy kindergarten, pet stores, dog parks, etc.) before they are fully vaccinated at 16 weeks plus allow 2 weeks for vaccines to become effective (18 weeks) to reduce the risk of deadly viruses (such as Parvovirus). Failure to do so, should the puppy be diagnosed with deadly virus, will void this health guarantee.
8. **SELLER ASSUMES NO RESPONSIBILITY FOR ANY HEALTH-RELATED ISSUES OR LOSS OF LIFE DUE TO REACTIONS CAUSED BY VACCINATIONS OR FLEA AND TICK PREPARATIONS ADMINISTERED BY ANY PERSON, EITHER ORALLY OR ON THE SKIN SURFACE. SELLER DOES NOT RECOMMEND THE USE OF ANY TYPE OF ORAL FLEA/TICK TREATMENT. SOME PRODUCTS HAVE BEEN KNOWN TO CAUSE ILLNESS AND EVEN DEATH. USE OF SUCH PRODUCTS VOID YOUR HEALTH GUARANTEE! (FULL RECORDS WILL BE REQUESTED FROM YOUR VET)**

If all of the conditions of this agreement have been met, and the Buyer desires to return the medically diagnosed dog, Willow Paw will have the option, at our discretion, to either replace the puppy from the next available litter or refund half the original purchase price. Return shipping of the original puppy, and shipping of the new puppy will be at the Buyer's expense. If the Buyer desires to keep the puppy, Willow Paw will pay for all Veterinary costs for treatment up to the full purchase price of the puppy paid to Buyer's Veterinarian.

**Willow Paw offers lifetime support with all of our puppies. If at any time the Buyer decides he/she no longer wants the puppy/dog, or can no longer care for it, we will take the puppy/dog back at any time, for any reason, with NO REFUND. If at any time Buyer should choose to re-home the puppy/dog, Buyer agrees to contact Seller to help place the puppy/dog in a new home. At NO GIVEN TIME should this puppy/dog be surrendered to the SPCA, Humane Society, dog pound, given away, etc.**

Buyer Agrees to Spay/Neuter. The Buyer understands this puppy is being sold as a pet and under **NO CIRCUMSTANCES WILL BE BRED**. The breeding of this puppy/dog is **NOT** an option. The puppy must be spayed or neutered by the age of 6 months. Buyer agrees to furnish Willow Paw with a spay/neuter certificate within **2 weeks** of spay/neuter deadline, at which time the sale of the puppy is complete and ownership officially transfers to the Buyer. If Buyer does not provide proof of spay/neuter signed by a licensed

Veterinarian within the allotted time, OR if the dog has been bred by purpose or accident, Buyer agrees to immediately pay the sum of **\$15,000**, which is the average cost of a Goldendoodle breeding dog. Furthermore, Buyer agrees to pay Seller **\$3,000** per puppy should any puppies be born as a result of failure to spay/neuter. Buyer also agrees to relinquish all rights of dog and its offspring (if applicable) should the dog be bred in breach of this contract, and the Seller has the right to reclaim the dog and its offspring (if applicable).

By signing below, the Buyer is indicating in a legally binding fashion that they have read, understand and agree to all conditions and terms set forth in this agreement. The Buyer further understands and agrees that any breach of this contract by the Buyer may result in repossession of the above-mentioned puppy/dog by Seller. Any expenses, incurred by Seller to enforce this agreement shall be the responsibility of the Buyer, including but not limited to: legal expenses, other fees, mileage, costs involved with reclaiming/reposessing puppy/dog, etc. All terms, and health guarantees shall be considered null and void should the Buyer be in breach of any portion of this agreement. No refunds will be issued by the Seller if the Buyer voluntarily relinquishes ownership for any reason, or if any breach of agreement by the Buyer results in repossession of the above-named puppy/dog. All court claims will be held in Bedminster, NJ.
